**2018 Farm Bill**

The 2018 Farm Bill removed hemp from the Controlled Substances Act and contained other key updates, including:

- ▶ Providing green light for banking, investing and insuring hemp-derived cannabidiol (CBD) products; and
- ▶ Barring the creation of laws prohibiting the interstate transportation of hemp or CBD derived from hemp.
