A NOTE FROM THE CHAIRMAN

In the post-pandemic era, China-based companies face unprecedented challenges and, but at the same time, a plethora of opportunities that may not have been readily apparent as recently as a year ago. The corona virus pandemic has essentially accelerated a range of geopolitical tensions that have made even traditionally fraught relationships more strained, particularly as it relates to China's relationship with the United States. This relationship is placing new pressures on PRC-produced goods, which is also of obvious concern for those U.S. companies with significant sourcing from China.

These dynamics simply serve to underline the strategic inflection point that China and U.S. companies now face: how to remedy the myriad of supply chain challenges. Or, in the more intriguing and possibly most insightful reset, is the U.S. poised to resume some measure of its historical capacity as a high-functioning R&D and manufacturing locus, in which market China needs to participate? None of these decisions are easy, nor should they be. The factors at play implicate every aspect of the Chinese and U.S. economies, as well as the destiny of companies confronted with such tactical decision points.

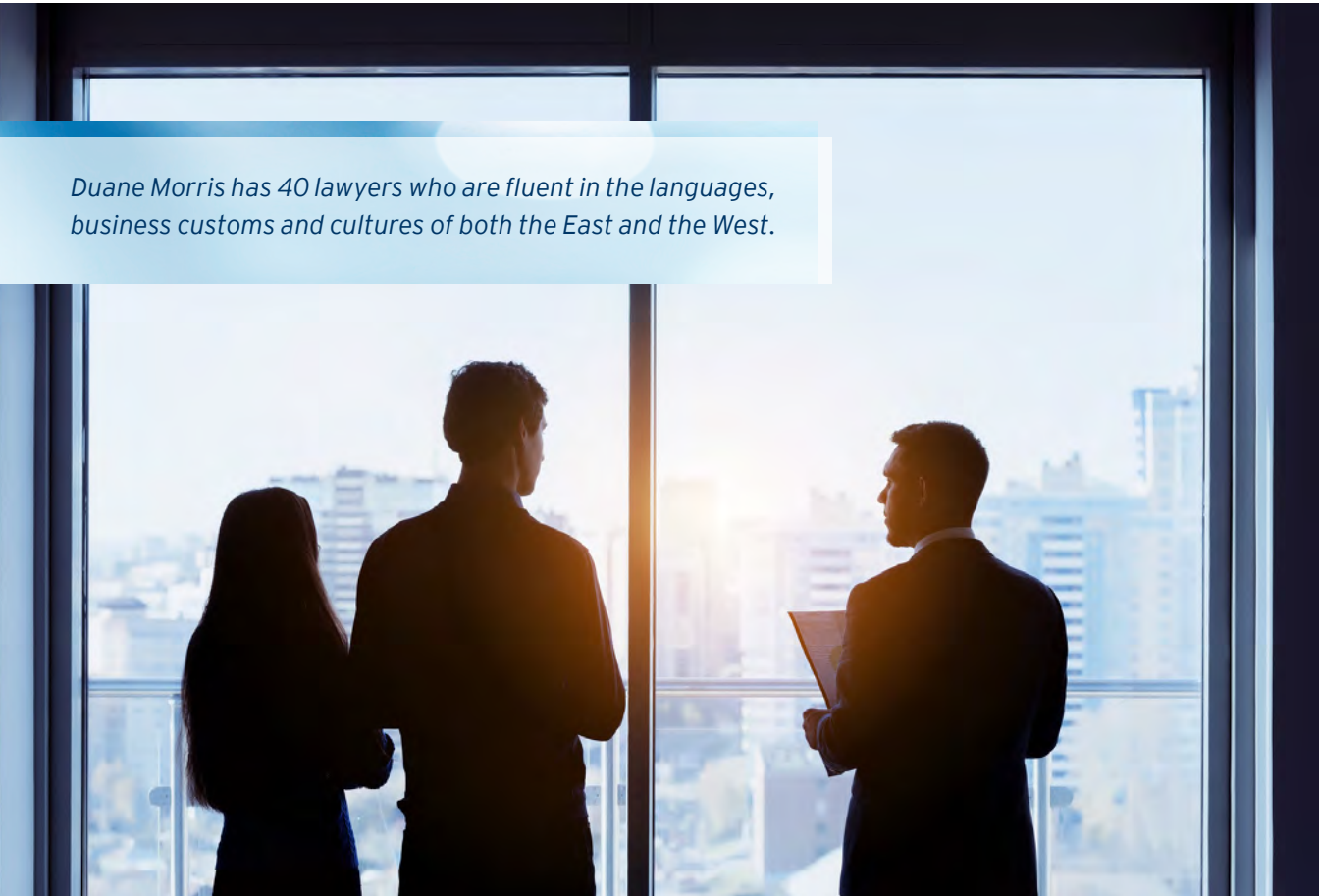

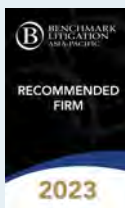

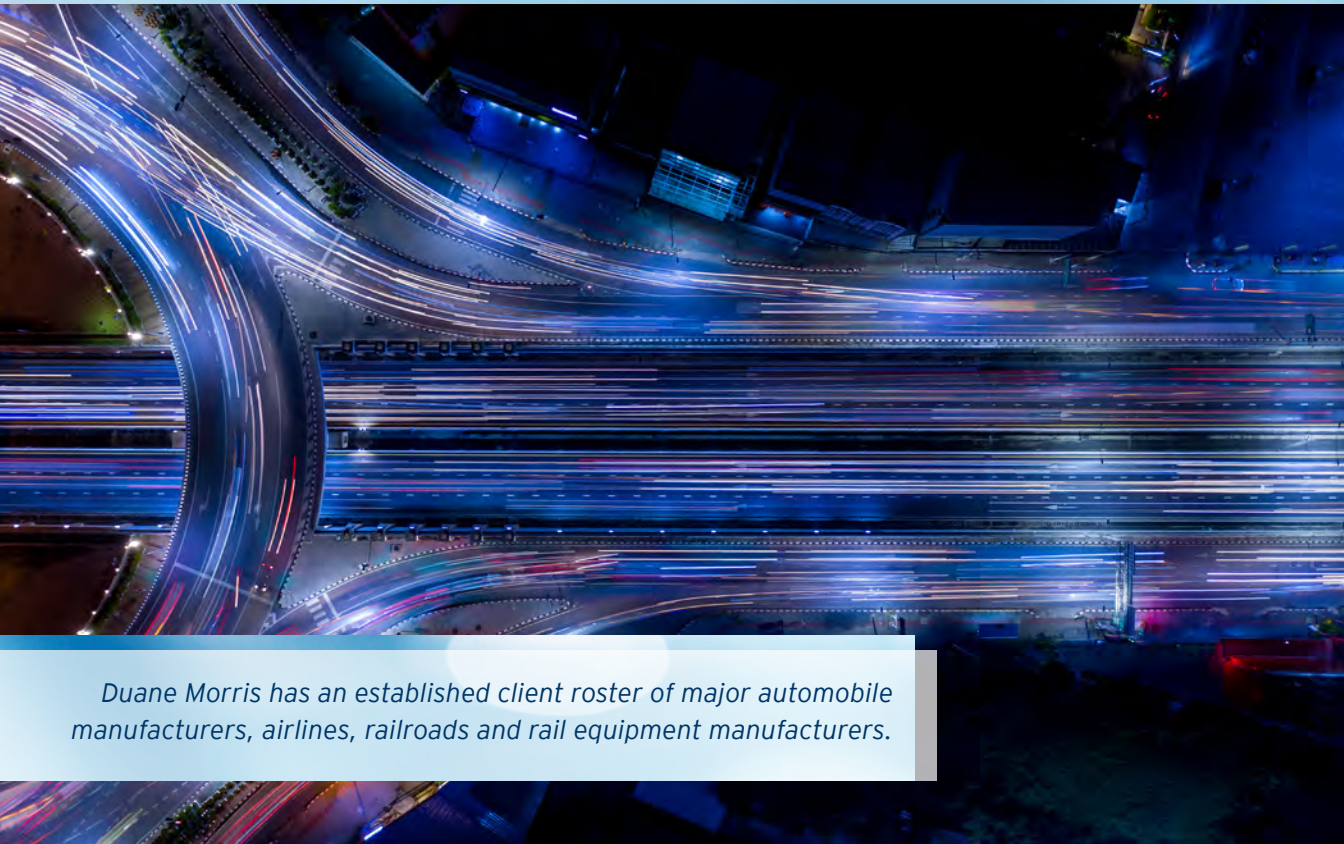
